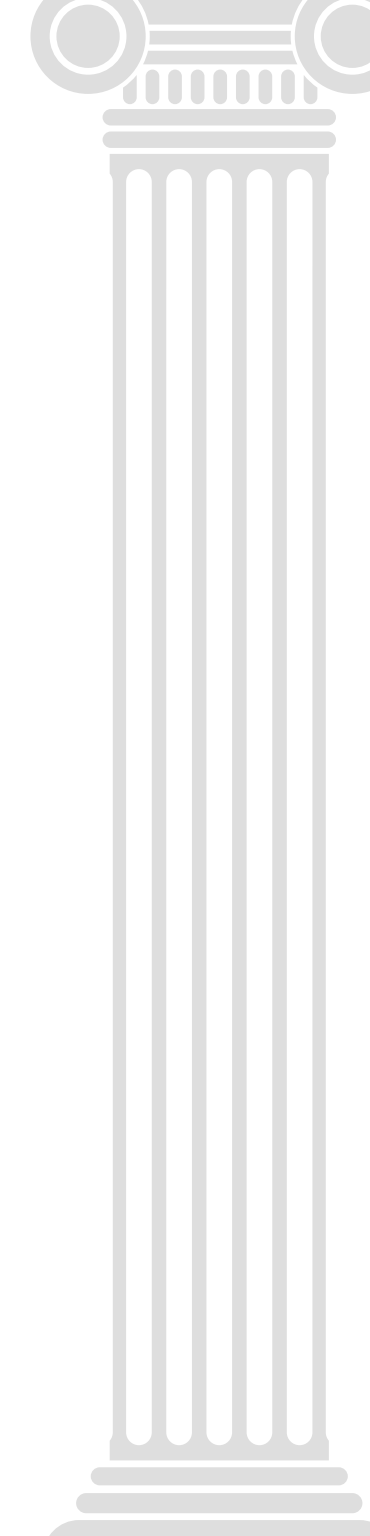
### ... always transparent

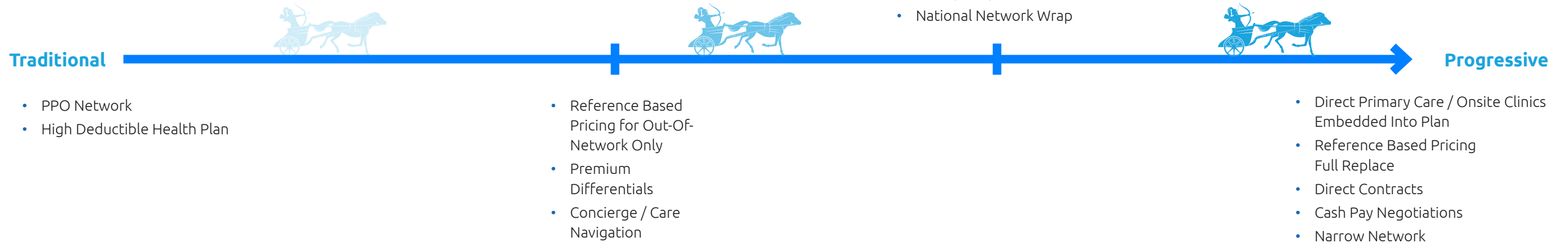
### ... it's liberating to be independent

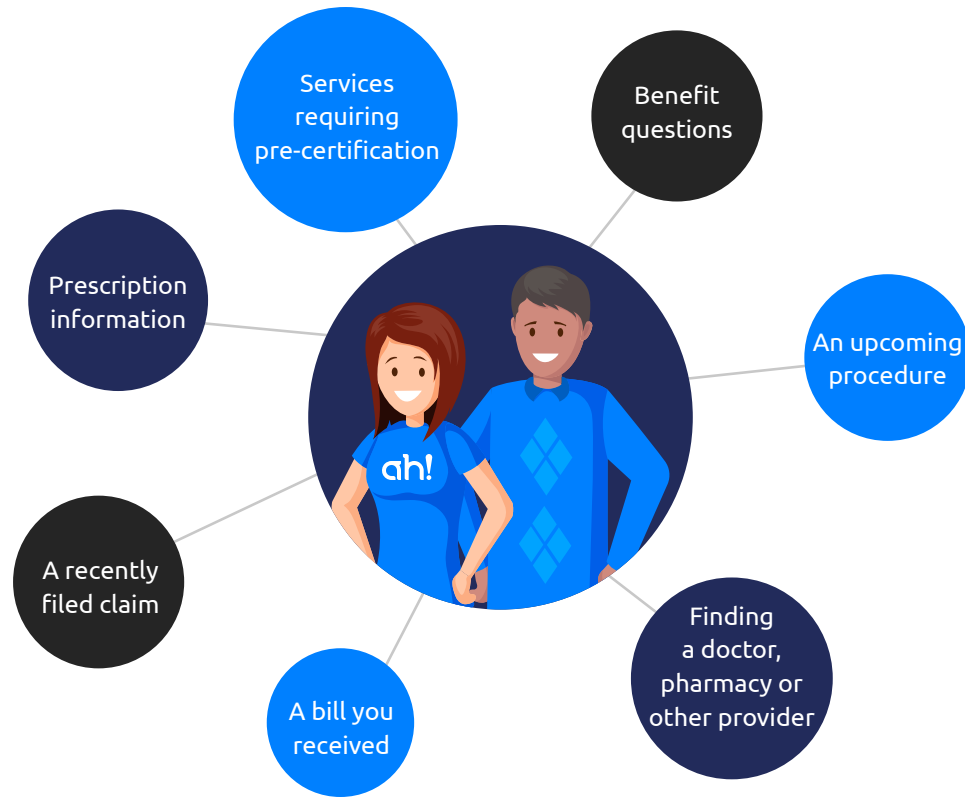
